Members considered quotations submitted from Reveal Media Ltd and Pinnacle Response Ltd. There are funds available from the Rolling Capital Fund to finance this expense.

#### **RESOLVED**

That members approve under power of LGS1972 S145 to purchase 4 body cameras for the value of £2,251 plus £116 for the annual maintenance excluding VAT.

## 7. QUOTE FOR CROWD CONTROL BARRIERS

Members discussed a quote from MTM Plant & Sales Ltd. There are funds available from the Rolling Capital Fund to finance this expense.

#### **RESOLVED**

That members approve under power of LGA1972 S145 to purchase 40 barriers for the value of £1012.40 excluding VAT.

## 8. FUNDING FOR "GROW YOUR OWN COMMUNITY SUDBURY" PROJECT

Members discussed a possible funding contribution for the project in the sum of £10,200 proposed by the November full council meeting.

#### **RESOLVED**

That members agreed that Sudbury Town Council will continue to support the project through the provision of our Community Wardens' assistance, however there are no financial funds available to support project costs for ongoing delivery of the service.
