Item 10 Motion

Whilst cautiously optimistic that the Delphi site has been purchased by a commercial development company, this Sudbury Town Council confirms its commitment to support the continuation of the total Delphi site being retained for Industrial and Leisure use for the benefit of the whole of the community of the Sudbury area.

The Delphi Industrial site at the peak of production supported the Employment of over 2,400 employees from all areas of Suffolk, whilst being disappointed at its demise, the current situation makes even more imperative that the site remains for the sole purpose of employment use.

The Delphi Social & Sports Centre has been an excellent facility for Sport, Social & Leisure activities since 1964/65 and until recently has seen many clubs and activities continue to flourish from the use of the facility, resulting in hundreds of local users. It contains one of the best 'public' sports fields in the Sudbury area and until recently entertaining a Youth Football club.

We call on Babergh & Mid Suffolk District Council and Suffolk County Council to use all of their powers to ensure that it continues to benefit the local community in its Employment and Social needs.
