## 7. DELEGATED POWERS OF TOWN CLERK

The RFO had raised concerns about non-compliance with Financial Regulations when employing staff. The Town Clerk had sought advice from the Chair of the HR committee regarding employment of staff replacing a staff member who had resigned. It was mutually agreed at the time that as the engagement was under budget that the appointment would be advised at the next HR meeting as part of the 'staffing update'. However members agreed that the wording of 7.3 of the Financial Regulations specifies that 'no changes be made to any employee's terms and conditions' and that this should apply to all replacement staff.

Cllr. Antill recommended that the Town Council adopts a 'scheme of delegation' used in other Town Councils which makes it clear what the agreed delegated powers of all staff should be.

#### **RECOMMENDED**

That 7.3 of the Financial Regulations remains in place but a 'scheme of delegation' is agreed at a future P&R meeting for adoption by Full Council.

## 8. FORWARD WORK PLAN

The Forward Work Plan was noted by members.

Members requested that the formulation of a 'scheme of delegation' policy be added to the Forward Work Plan.
